UPDATING TAXPAYER INFORMATION

The Fiji Revenue & Customs Authority (FRCA) is currently undertaking a Data Cleansing Project to update all Taxpayer Registration Information.

This initiative is undertaken to provide efficient taxpayer services that will enable online lodgements, payments, real-time updates and access to your tax information. This will be made possible in future with the introduction of a **robust Online Taxpayer Portal**.

Before the system is upgraded, FRCA will verify your information details that is currently captured in their system. If FRCA has correctly captured your information, this will make it much easier for you to access their services, comply with tax laws and for FRCA to provide the necessary advice and support.

As there is a very large group of taxpayers, data cleansing will be done in phases. FRCA will begin this exercise with Companies.

Authorized officers are required to complete the 2017 Information Update Form affixed with Official Company Stamp by **30th June 2017**.

Completed forms can be delivered to any FRCA Office or emailed to atacleansing@frca.org.fj.

The 2017 Data Update Form is available on FRCA's website (<http://www.frca.org.fj/taxation-forms-tax-registration-change-of-address/>) or can be collected from any FRCA Office.
